Article 1 – Name

The name of the Organization shall be Chinese Golden Age Club of Mississauga. The abbreviation is CGAC.

Article 2 – Policy

The Organization shall be non-political and non-profit. It shall be operated democratically in accordance with parliamentary rules of order.

Article 3 – Objectives

Directors (8)

The five officers plus 8 directors constitute the Board of Directors. Major decision must be approved by the Board of Directors. Any expense beyond 100 dollars must be approved by the Board of Directors.

(b) Term of Office

Term of the office shall be two years.

Officers shall be elected at an Annual General Meeting hold in November of the election year.

Article 6 – Duties

President – representing the club, chair the board meeting, chair the Annual General Meeting.

Vice-President – assist the President.

Secretary – Keep minutes of all meetings.

Treasurer – Responsible for all financial transactions, prepare annual report.

Directors – Responsible for functions assigned in the board meeting.

Article 7 – Meetings

A Quorum of 50% plus one is required for a decision.
